

Texas and the North line of the said Caddo Mills tract to the POINT OF BEGINNING and containing 50.22 acres of land.

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS: THAT GLA Ventures, LLC does hereby adopt this plat as CADDO CROSSING PHASE I, an addition to the City of Caddo Mills, and do hereby dedicate to the use of the public forever the rights of way, public use areas and other easements shown thereon for the purposes indicated; THAT said easements may be for the mutual use and accommodation of all public utilities serving the property, unless an easement limits the use to particular utilities, with all uses being subordinate to that of the City of Caddo Mills; THAT the said City and public utilities shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs or other improvements or growths, which may in any way endanger or interfere with the construction, maintenance or efficiency of their respective systems located within said easements; THAT the said City and public utilities shall at all times have the right of ingress to and egress from their respective easements for the purpose of constructing, reconstructing, inspecting, patrolling, maintaining, reading meters, and adding to or removing all or parts of their respective systems without the necessity at any time of procuring permission from anyone; and further, THAT the Owner(s) do hereby acknowledge the requirement of completion of all water and sewage collection systems (if any) and all street, curb and gutter and drainage improvements (if any) at the expense of the Owner(s) and guarantee(s) the performance of same. The Owner(s) further acknowledge that the public infrastructure improvements imposed by the City of Caddo Mills as a condition of plat approval are roughly proportionate to the demand created by the development on the public infrastructure improvements do not impose costs on the developer
